## 3.2.1 <u>TO CONSIDER REPORTS OF THE DIRECTOR OF SERVICES, STRATEGIC</u> <u>PLANNING & ECONOMIC DEVELOPMENT & ENTERPRISE STRATEGIC</u> <u>POLICY COMMITTEE, ON THE FOLLOWING MOTION WHICH WAS</u> <u>REFERRED TO THE COMMITTEE BY AN CHOMHAIRLE:</u>

An Chomhairle considered and approved the report of Director of Services dated the 27<sup>th</sup> August 2015 on the following motion which was referred to the Committee by An Chomhairle.

## **REVISE THE BISHOPSTOWN WILTON AREA ACTION PLAN**

'That Cork City Council would review and revise the Bishopstown Wilton Area Action Plan by commissioning a Local Area Plan'.

(Proposer: Cllr J. Buttimer 15/195)

The report of the Director of Services stated that the Bishopstown Wilton Local Area Plan was prepared in 2008 and the key policies and proposals were incorporated into the 2009 City Development Plan. These policies were reviewed and where appropriate updated as part of the preparation of the City Development Plan 2015-2021.

Local Area Plans (LAPs) are statutory plans intended to be prepared for areas which have significant potential for new development or in need of significant regeneration. Resources to prepare such plans are limited and it therefore necessary to prioritise the areas that would most benefit from them. On this basis the South Docks and Tivoli Docks have been identified for updated and new LAPs respectively, in the new City Plan.

Bishopstown Wilton is an established suburb of Cork City which does not have significant potential for new development and is not in need of significant regeneration. It is therefore

not a priority for the preparation of a Local Area Plan. There are a small number of sites for development and the framework for these is already set by the development Plan.

There may also be a number of specific issues that are of concern to local people, some of which are capable of being addressed by Cork City Council and some which are outside the local authority's area of influence. These issues would be most rapidly and effectively dealt with by recourse to the relevant Directorate rather than dedicating significant resources and time to preparing a statutory Local Area Plan.

I recommend that the Committee note the position and refer the report to An Chomhairle for information.

## 3.3 <u>STRATEGIC PLANNING , ECONOMIC DEVELOPMENT & ENTERPRISE</u> <u>FUNCTIONAL COMMITTEE – 31<sup>st</sup> AUGUST 2015</u>

#### 3.3.5 **DERELICT SITES REPORT SOUTH CENTRAL WARD**

An Chomhairle considered the report of the Director of Services, Strategic Planning & Economic Development dated 27<sup>th</sup> August, 2015 on the Derelict Sites Report South Central Ward.

An tArdmhéara and the Chief Executive wished Mr. J. Beecher, Administrative Officer, Strategic Planning, Economic Development & Enterprise well in his retirement and thanked him for his service with Cork City Council.

### 3.4 MOTIONS

An Chomhairle agreed to hold Items No. 3.4.1 to 3.4.4 in Committee and the Director of Services to revert with reports.

## 3.4.1 <u>NEW NON – COMPETING RENTAL AND COMMERCIAL SERVICES</u>

'New non –competing rental and commercial services aimed at new initiatives that have not traded in Cork in the past two years and that will not compete directly with existing enterprises. The grant to be applicable for new developments or for premises vacant for at least three months. The grant relief to be 100% for first three years (Blackrock Village, Blackpool, derelict inner city areas).'

(Proposer: Cllr. S. Martin 15/141)

### 3.4.2 OFFICE REFURBISHMENT CITY CENTRE

'That Cork City Council facilitate refurbishment for new office accommodation and upgrading of existing offices excluding (equipment and furnishings). The grant to operate in a sliding scale of 100% to 25% over first three years.'

(Proposer: Cllr, S. Martin, T. O'Driscoll 15/143)

## 3.4.3 <u>ART CRAFT ARTISAN FOOD SHOPS IN OLD HISTORICAL CITY SPINE</u> (BARRACKS STREET TO SHANDON)

'A grant applicable for commercial premises that have been vacant for over three months and measuring less than 40sqm. The grant to offer 100% municipal rate payable for the first three years'.

(Proposer: Cllr. T. O'Driscoll, S. Martin 15/144)

### 3.4.4 <u>FIT-OUT FOR NEW CLOTHING, FOOTWEAR ENCOURAGING NEW</u> <u>BUSINESSES</u>

'That Cork City Council pay a grant only to occupy commercial premises that have been vacant for at least three months. The grant to provide 100% rates paid for the first year.

(Proposer: Cllr. T. O'Driscoll, S. Martin 15/145)

## 3.4.5 <u>THAT NO 1 PARKGATE VILLAS, BISHOPSTOWN ROAD BE DECLARED</u> <u>DERELICT AS IT IS NOW A DANGEROUS STRUCTURE</u>

An Chomhairle considered and approved the report of Director of Services dated the 27<sup>th</sup> August 2015 on the following motion which was referred to the Committee by An Chomhairle.

'The above old unoccupied dwelling is a complete "eye-sore" and in a dangerous state with holes in the roof and loose slates. Slates have already fallen onto the main Bishopstown Road and footpath. Structurally there are large open cracks in the main walls of the house. There is large amounts of rubbish piled up in the back yard which is a health hazard and a habitat for rats and other vermin. It is also used by drinking parties at night time and is constantly used as a toilet.

I am requesting the Manager to have this structure assessed without delay and because of this house being situated so close to the busy main road there is a huge danger to the public, vehicles etc by slates falling or a further deterioration to the structure.'

(Proposer: Cllr. M Shields 14/285)

The report of the Director of Services dated the 27<sup>th</sup> August 2015 stated that:-

"This building has been assessed and is considered derelict. The Strategic Planning & Economic Development Directorate is currently instituting proceedings under the Derelict Sites legislation to place it on the Derelict Sites Register".

I recommend that the Committee note the position and refer the report to An Chomhairle for consideration.

### 3.4.6 TAX INCREMENT FINANCE AND COMMUNITY INVESTMENT FUNDS

An Chomhairle considered and approved the report of Director of Services dated the 27<sup>th</sup> August 2015 on the following motion which was referred to the Committee by An Chomhairle.

'That Cork City Council expands the use of business improvement districts and new financial tools to create fresh financial opportunities for Local Authorities and Businesses to invest new urban projects such as Tax Increment Financing and Community Investment Funds'.

(Proposer: Cllr. S. Martin 15/176)

The report of the Director of Services stated that Business Improvement Districts were considered in the preparation of the City Centre Strategy. Following consultation with stakeholders, it was decided that, as it would involve additional charges on businesses, it was not the appropriate time to proceed with this type of initiative.

Tax Increment Financing has long-term implications for future revenues that would need to be analysed and understood before embarking on initiative using this type of instrument. These implications should be fully considered by the Finance Committee and a report prepared for Council.

I am unaware of any community investment funds currently available for Cork City Council to access. The City Council has the capacity to create its own fund as it prepares the budget for 2016.

I recommend that the Committee note the position and refer the report to An Chomhairle for consideration.

## 3.4.7 LOCAL DEVELOPMENT PLAN FOR TURNERS CROSS

An Chomhairle considered and approved the report of Director of Services dated the 27<sup>th</sup> August 2015 on the following motion which was referred to the Committee by An Chomhairle.

'That a Local Development Plan be prepared for Turners Cross. The plan to encompass:-

- 1. Transport infrastructure
- 2. Community Facilities
- 3. Dereliction
- 4. Supports to encourage regeneration of existing housing stock
- 5. Assessment of Social Capital

(Proposer: Cllr. S. Martin 15/179)

The report of the Director of Services stated that the Planning & Development Acts 2000 - 2014 provides that a planning authority may prepare a local area plan for areas likely to be subject to large scale development within the lifetime of the development plan.

Departmental Guidelines specifies that Local Area Plans are intended to provide detailed planning policies for areas that are expected to experience significant development and change. In accordance with the Guidelines, the City Development Plan sets out priority development areas such as the City Centre, Docklands and Tivoli.

Turners Cross is an established neighbourhood of Cork City which does not have significant potential for new development and is not in need of significant regeneration. It is therefore not a suitable area for the preparation of a Local Area Plan. The significant resources required to carry out a Local Area Plan, would be more effectively employed in directly addressing issues, such as traffic management, dereliction and community facilities.

I recommend that the Committee note the position and refer the report to An Chomhairle for consideration.

#### 3.4.8 **ZONE PRINCES STREET AS A STREET DINING ZONE**

An Chomhairle considered and approved the report of Director of Services dated the 27<sup>th</sup> August 2015 on the following motion which was referred to the Committee by An Chomhairle.

'That Princes Street be made on – street dining zone, a tourist and a food destination that we would zone the Princes Street for the on Street Dining concept.

(Proposer: Cllr. K. O'Flynn 15/214)

The report of the Director of Services stated that the City Council's vision for Princes Street is set out in the *Cork City Development Plan 2015-2021*, and the background *Cork City Centre Strategy* (2014). Princes Street forms part of the City Centre Retail Area, which prioritises retail uses but encourages active uses in the area that contribute to the character and life of the City Centre, such as hospitality uses. The City Centre identifies

the potential for Princes Street to be developed as a "Restaurant Street" with outdoor seating, with a view to creating an attractive street environment and a food and drink destination with a strong brand for this. This is included in the City Centre Strategy Implementation Plan. Hospitality uses are compatible with the zoning objective / development objectives for Princes Street and are encouraged as a key contributor to the "vitality and attractiveness" of the City Centre in *Objective 13.1: Strategic Objectives: City Centre and Docklands* of the CDP2015-2021.

The occupation of streets is subject to s254 licences under the *Planning and Development Act 2000* (as amended), and is not a matter for the development plan. The policy and standards for the licensing of streets and spaces is set out in *Directions for the Management and Control of Roadworks in Cork City (Cork City Council, 2010).* 

Work has been underway by the City Council in partnership with the Princes Street traders during 2015 to work towards Princes Street being recognised as a mixed use commercial street with a strong food and drink profile and developed as an outdoor food street destination. The Princes Street Food Street Pilot Project 2015 has provided a framework for food and drink businesses to apply for s254 street licences for outdoor seating and these are currently being processed with a view to the street being colonised for the remainder of the year to explore the benefits of this for the street and its business community, as well as wider City Centre revitalisation and policy / standards. Similarly, Little Cross Street has been colonised as a special pilot project in 2015 to provide street life in the Washington Street urban village.

As zoning is a long term measure, it does not have the flexibility necessary to address initiatives such as street dining zones. In addition, as indicated here, the current zoning allows for these initiatives to be supported.

I recommend that the Committee note the position and refer the report to An Chomhairle for consideration.

#### 3.4.9 ENHANCING TWINNING ARRANGEMENTS WITH COLOGNE

An Chomhairle considered and approved the report of Director of Services dated the 27<sup>th</sup> August 2015 on the following motion which was referred to the Committee by An Chomhairle.

'That Cork and Cologne explore new ways of enhancing our twinning arrangement following the decision of Aer Lingus to commence direct flights from Cork to Dusseldorf in 2016.

N.B. Dusseldorf is just 25 miles from Cologne'.

(Proposer: Cllr. T. O'Driscoll 15/232)

This motion has been referred to the International Relations Committee who will report.

# 3.5 <u>TOURISM ARTS & CULTURE FUNCTIONAL COMMITTEE – 7<sup>th</sup> SEPTEMBER</u> 2015

## 3.5.1 **MOTION**

An Chomhairle considered and approved the report of the Director of Services on the following motion which was referred to the Committee by An Chomhairle,

## FLY THE TRICOLOUR ON CORK CITY COUNCIL BUILDINGS

"That Cork City would ensure that all public buildings owned or that Cork City Council have interest in would fly the tricolour everyday of the year in 2016 to commemorate the 1916 anniversary"

(Proposer: Cllr. K. Collins 15/189)

The report of the Director of Services stated that it is the intention that the Tricolour will be flown at all major public buildings under the control of Cork City Council during 1916 subject to national protocol for the display of the Tricolour. Also, it is proposed that other building owners, institutions and businesses will be written to and encouraged to display the Tricolour throughout the year subject to the same protocols, and will be further encouraged to replace worn or otherwise unsightly copies of the Tricolour.

# 3.6 FINANCE & ESTIMATES FUNCTIONAL COMMITTEE – 7<sup>th</sup> SEPTEMBER 2015

## 4.1 AWARDING OF CATERING CONTRACTS

In response to the following question submitted by Comhairleoir M. Nugent, a written reply was circulated as outlined below:-

Can the Chief Executive outline the process in which City Council awards its catering contracts? Are there any obligations for the successful tenderers such as the payment of a decent wage and adequate terms and conditions for its employees?

## REPLY

The Canteen catering contract was awarded under Cork City Council's Procurement Policy and Guidelines. Internal catering also complies with such Policy and Guidelines.

All contactors, catering or otherwise, are required by Cork City Council to complete and sign a "Contractors Certificate of Compliance" which states that the contractor complies with the relevant Irish employment laws and regulations including rates of pay, conditions of employment, safety health and welfare and Pension obligations.

#### 4.2 STREET FURNITURE LICENCE

In response to the following question submitted by Comhairleoir K. O'Flynn, a written reply was circulated as outlined below:-

How much was raised by Cork City Local Authority from the street furniture licence programme in 2015, 2014, 2013 and 2012?

How much does it cost Cork City Local Authority to administer and police the programme?

How many businesses are licenced in the local authority area?

Finally, how much profit does the local authority benefit from the programme?

#### REPLY

1. The following fees are applicable for Street Furniture Licences:

Application Fee €110 Fee per table €125 Fee for use of public space €100

The following is the total combined income for Street Furniture for the respective years:

 $2015 - \pounds 48,775$   $2014 - \pounds 48,253$   $2013 - \pounds 31,030$  $2012 - \pounds 23,370$ 

- 2. The administration of the licences involves the Roads Directorate, Planning Directorate, Fire Department and Law Department and costs approximately €50,000 per annum to administer.
- 3. 90 business are licenced for 2015.

4. The local authority does not profit from Street Furniture Licences.

## 4.3 CORK EVENT CENTRE

In response to the following question submitted by Comhairleoir M.Finn, a written reply was circulated as outlined below:-

Mindful of the fact that the BAM promoters insisted they could press ahead with the Cork Event Centre project irrespective of public funds, and given the 10 months period delay since the former Beamish & Crawford site was selected as the preferred option, can the CE please explain the inordinate delay in progress and perhaps agree that the selection process should be re- started?

### REPLY

The delay in formal contract signing to allow works to begin on this project while unsatisfactory from our point of view is not untypical of projects with this level of complexity and risk. While we are disappointed with the pace of progress since selection of the preferred bidder it is not in the interests of the Council to restart a lengthy selection process the outcome of which would put us in the position of where we were 10 months ago.

#### REPLY

The Irish Water Logo, located on the right-hand side of the masthead on the Cork City Council website home page, is a shortcut to <u>www.water.ie</u>.. This is activated by double clicking the graphic.

Consequent on transfer of responsibility for provision of Water Services from local authorities to Irish Water in January 2014, Cork City Council placed a link on its homepage to facilitate easy transfer to www.water.ie, in order to seek further information or post requests for service.

## 4.5 **<u>PUBLIC LIGHTS</u>**

In response to the following question submitted by Comhairleoir S. Martin, a written reply was circulated as outlined below:-

- a) How many public lights are not working because they require Capital investment?
- b) How much finance is required to complete these works?
- c) Is there money in place to carry out the works?

### REPLY

At present there is a total of 582 lights (representing **4%** of the total inventory of street lights) out of order awaiting repairs or lantern replacement. Of these, it is estimated 137 lights will be fixed by Airtricity Utility Solutions (AUS Ltd.) under their routine maintenance obligation but up to 40 locations require attendance by ESB Networks to get a number of lights or schemes back in operation. A further 237 lantern will be repaired on the Public Lighting Replacement & Renewal programme in 2015 at a cost of €301,000. The related work programme is being progressed at present and will be completed by AUS Ltd. before the end of this financial year. The remaining 208 Lights Out of Order will be repaired from January onwards under the 2016 Public Lighting Replacement & Renewal programme at an estimated cost of €265,000.

#### 4.7 **PENROSE QUAY HOARDING**

In response to the following question submitted by Comhairleoir K. McCarthy, a written reply was circulated as outlined below:-

To ask the CE for an update on the Penrose Quay hoarding? Whilst acknowledging, the recent creation of a smaller hoarding space, it is now six years since my initial asking of when this remnant of the Cork Main Drainage Project will be completed and the site levelled off?

## REPLY

As stated the hoarding on Penrose Quay was considerably modified and made more secure, earlier this year.

As previously indicated, it is intended that necessary venting works at the siphon location on Penrose Quay, will be carried out in tandem with the public realm and road improvement scheme for the area. This project is currently in the procurement phase and is expected to commence on site before year end, with completion in first half of 2016.

### 4.8 **<u>NEW PONTOON ON THE MARINA</u>**

In response to the following question submitted by Comhairleoir N. O'Keeffe, a written reply was circulated as outlined below:-

Can the Chief Executive please advise the following information relating to the new pontoon on the Marina:

Who is responsible for the operation of the pontoon?

Which clubs and groups will use the pontoon? Is the pontoon available for members of the public to utilise?

What are the arrangements for the opening and closing of the pontoon? What are the hours of operation? Will these hours vary seasonally?

## REPLY

The City Council is responsible for the operation of the new public pontoon at the Marina. The pontoon access is gated for health and safety reasons, as the gangway leads down to an open pontoon located in deep water.

At present, a number of boat clubs and maritime organisations such as Meitheal Mara, Cork Dragons etc have access to the facility. It is planned to have a fixed presence shortly on site at weekends to facilitate greater access by the public, hours of opening being tailored to meet demand.

#### 4.9 **BOILER SERVICES**

Taking into consideration that 7.263 tenants have their rents increase for to cover the cost of boiler services, would the CE now be returning the moneys to those tenants that have

not had their boilers serviced in 2015 or into the fact that only 3102 boilers have been serviced to date?

## REPLY

No.

The number of boilers serviced to date now stands at 3138. All boilers will be serviced by years' end unless there is a difficulty either carrying out a service (e.g. no gas supply to the boiler), the tenants refuse entry or the tenants do not make themselves available to facilitate a service.

The tenants who identify themselves as not having received a boiler service should report this immediately to the Council's help line.

What is Cork City Council's role in same?

## REPLY

Since 1<sup>st</sup> February 2013 Cork City Council has been responsible for the issuing and renewing of licences for the use of bus stops. This is in accordance with SI 12 of 2013 and Section 16 of the Road Traffic Act 2002, Prior to this, the responsibility rested with An Garda Síochána.

Bus shelters are provided and maintained by the bus operator. Cork City Council has no involvement in the maintenance of bus shelters.

## 4.11 MARKET GARDENS, TOGHER

In response to the following question submitted by Comhairleoir F. Dennehy, a written reply was circulated as outlined below:-

Following the lighting fault which put Market Gardens in Togher in darkness for a considerable period of time, can the Chief Executive confirm if a maintenance contract is in place with Airtricity to maintain the street lights in this estate.

Can the C E also confirm what departments are responsible for maintenance of roads, green spaces and trees in Market Gardens?

## REPLY

Market Gardens is an estate that was developed by the Housing Directorate and consists of a mixture of affordable units and social units. Roads matters remain the responsibility of the Housing Directorate, until the estate is formally taken in charge.

A maintenance contract is in place with Energia to maintain the street lights in the Market Gardens estate.

The Parks Division is responsible for the maintenance of green spaces and trees within Market Gardens.

## REPLY

- 1. The Nash's Boreen travellers site is located on land owned by Cork City Council but within Cork County Council's administrative boundary.
- 2. The travellers site is unauthorised. Cork City Council provide limited support to the residents of the site which include provision of skips and portable toilets.
- 3. There are no plans to supply electricity at this location as the traveller site is unauthorised.

Dublin City Council has recently invited modular housing suppliers to display their product on a site at East Wall Road. This initiative was in the context of a debate on the possibility of using modular housing as an alternative short term provision option for the numbers of homeless families in Dublin residing at present in hotels.

The technical aspects of compliance with building & planning regulations are currently being examined.

Cork City Council currently considers the use of modular pod bathrooms in respect of extensions and adaptations for persons with a disability where feasible and economically viable.

The report of the Director of Services stated that further to Councillor Buttimer's revised query issued to the Property Department in July 2015 that the properties outlined in the table below represent all non-residential property acquisitions by Cork City Council since 2010. The method of acquisition, price and purpose of acquisition is outlined. As can be seen the vast majority of acquisitions over the period were to facilitate the delivery of strategic council objectives namely road widening or public park redevelopment plans. The parties involved in each transaction have been detailed save in the case of private individuals where it is considered that the information is not appropriate for disclosure.

The report further stated that no specific loans are outstanding on the properties. In the case of acquisitions for road widening the required monies would have been repaid by the National Roads Authority as part of the overall public funding for the project.

### 8.11 **PROPERTIES AT SKIDDY'S LANE**

An Chomhairle considered and approved the report of the Director of Services, Housing & Community Services dated 17<sup>th</sup> September, 2015 on the following motion referred to the Committee by An Chomhairle:

That Cork City Council include the Skiddy's Lane in Vicars Road and Pouldauff Road in the Fabric Upgrade Programme.

(Proposer: Cllr. S. Martin 15/174)

The report of the Director of Services stated that the Fabric Upgrade Programme commenced in May 2013 for social housing stock in the ownership of Cork City Council. The properties at Vicars Road and Pouladuff Road are in the ownership of Skiddy's Charity and therefore cannot be included in the Programme.

## 8.12 HOUSING APPLICANTS CONTACT DETAILS

An Chomhairle considered and approved the report of the Director of Services, Housing & Community Services dated 17<sup>th</sup> September, 2015 on the following motion referred to the Committee by An Chomhairle:

'That City Council would review the process for obtaining housing applicants contact details due to the enormous amount of applicants that are not contactable when they have been chosen to be given an offer of housing.'

(Proposer: Cllr. H. Cremin 15/203)

The report of the Director of Services stated that social housing support applicants fill out the Personal Details Section in the Application Form. The onus is on the Applicants to notify the Housing Authority of any change in their circumstances including their contact details.

#### 8.13 DAMAGE TO COUNCIL PROPERTIES CAUSED BY TENANTS

An Chomhairle considered and approved the report of the Director of Services, Housing & Community Services dated 17<sup>th</sup> September, 2015 on the following motion referred to the Committee by An Chomhairle:

'That Cork City Council should formulate a policy where tenants who wreck houses should be charged for the damage done and not given another Council house.'

(Proposer: Cllr. S. Martin 15/181)

The report of the Director of Services stated that it is the policy of the Housing and Community Directorate that where tenants have caused damage to properties above normal wear and tear that they will be required to make good such damage. In cases where this cannot be achieved, the costs of repairing damage or removing rubbish are calculated by the Housing Maintenance Section and are placed as a charge against the tenants rent account.

## 8.14 **COMMUNITY WARDENS**

An Chomhairle considered and approved the report of the Director of Services, Housing & Community Services dated 17<sup>th</sup> September, 2015 on the following motion referred to the Committee by An Chomhairle:

'Can Cork City Council look at supplying the four Community wardens with Cork City Council transport. The wardens are currently carrying out their employment duties in their own private cars. The council vehicles with the relevant signage will have the added benefit of promoting the services of the Community Warden who are a big part of the community.'

(Proposer: Cllr. K. Collins 15/218)

The report of the Director of Services stated that six Community Wardens were originally appointed by the City Council in August 2008; due to resignations there are now four wardens working in the RAPID areas of the City. Initially, funding was secured under the Sustainable Communities Fund and following the success of the initial pilot, the service was mainstreamed and is now funded wholly by Cork City Council.

The Community Warden's role was intended to cover three main areas:

- Community Liaison
- Monitoring of and Reporting of Local Authority Issues
- Enforcement of Local Authority Regulations

The report further stated that the Community Warden Initiative is an important support to communities in disadvantaged areas and provides a significant City Council presence in communities. A key aspect of the community wardens' role is to patrol their estates and identify any issues relevant to the Local Authority. The Wardens patrol the parks, specific estates and open spaces. Issues such as abandoned cars, litter, dumping, repairs and maintenance, etc. are reported to the appropriate Directorate/Agency and where possible proactive action is taken. Currently, this work is carried out on foot or by bicycle. This provides a very visible City Council presence in communities.

The report also stated that whilst a City Council van would add to the visible presence of the wardens in their areas and would assist them in carrying out their duties, the current budgetary provision is not sufficient to cover the cost of vehicle leasing. The non-staff budget allocated to the Community Warden Service in 2015 was  $\in 14,000$  which covers all materials, equipment, uniforms, mobile phones, rent and cleaning materials. The cost of vehicle leasing for four community wardens would be  $\in 10,464$  per annum plus fuel and insurance. There is no budgetary provision for vehicles.

On the proposal of Comhairleoir N. O'Keeffe, seconded by Comhairleoir T. Fitzgerald, An Chomhairle agreed to accept the report of the Director of Services that a new Part 8 consultation process for stages 1 and 2 of the City Centre Movement Strategy be undertaken.

#### SUSPENSION OF STANDING ORDERS

On the proposal of Comhairleoir T. Fitzgerald, seconded by Comhairleoir P. Dinnen, An Chomahirle agreed to adopt the Resolution.

## 9.9.1 LOCAL AREA TRANSPORT PLAN

An Chomhairle considered and approved the report of Director of Services dated 17th September 2015 on the following motion which was referred to the Committee by An Chomhairle.

'That a Local Area Transport Plan be carried out by Cork City Council for the South Parish Evergreen, Greenmount Road network. The Plan to look at one way systems, pedestrian crossing and Junction.

(Proposer: Cllr. S. Martin 15/180)

The report of the Director of Services stated that The South Parish Evergreen and Greenmount road network form part of the study area for South west Strategic Travel Corridor study and projects may be identified as part of the study.

Funding or resources are not available to prepare specific local area transport plans for individual areas at this time.

## 9.9.2 PEDESTRIAN ACCESS FROM ST VINCENTS GAA CLUB TO KILMORE ROAD

An Chomhairle considered and approved the report of Director of Services dated 17th September 2015 on the following motion which was referred to the Committee by An Chomhairle.

'That Cork City Council provide pedestrian access from the entrance of St Vincents GAA Club to Kilmore Road given the large number of children, players and officials attending the activities of the club.'

(Proposer: T. Fitzgerald 15/187)

The report of the Director of Services stated that **f**ootpath repairs were recently carried out at the junction of Dunnycove Crescent and Kilmore Road which will assist in access to St.Vincent's GAA club.

The request for the provision of a pedestrian access from St Vincent's GAA Club to Kilmore Road will be assessed. If deemed appropriate it can be put forward for consideration in any future roads programme.

In addition it should be noted that the Road Safety Authority (RSA) in association with the FAI, GAA, IRFU and Cycling Ireland has developed road safety guidelines for sporting organisations, entitled 'Play it Safe'

These guidelines present information on:

- organising sporting events with road safety in mind;
- encouraging the use of high visibility material;
- safe driving practices;
- other important road safety information

## 9.9.3 <u>REVIEW THE GREEN ROUTE ON THE NO 208 FROM BISHOPSTOWN TO</u> <u>CITY CENTRE</u>

An Chomhairle considered and approved the report of Director of Services dated 17th September 2015 on the following motion which was referred to the Committee by An Chomhairle.

'That Cork City Council would review the current Green Route on the No 208 from Bishopstown to City Centre particularly on the Wilton Road and Wilton Gardens stretch of road in light of the Garda statistics that show that since the inception of the "Green Route" on Wilton Road over 100 serious accidents have been caused as a direct result of the Bus Lane.

Wilton Road, at 9.3 meters, is too narrow to accommodate a Bus lane, 2 traffic lanes, cyclists and pedestrians safely. A possible solution may be to revert to 2 traffic lanes and create two 1.5m dedicated cycle lanes; the Impact on bus journey time would be negligible on this small stretch of road and would have a significant improvement in overall safety for all road users and residents.

Also to review the effectiveness of the yellow box closest to Dennehy's Cross, at the Harley Wood entrance by the church of the Descent of the Holy Ghost Dennehy's Cross. The Diagonal yellow box is confusing, ineffective and dangerous; it has been the scene of several serious accidents and daily road rage and confrontations. If Cork City Council takes the suggestion above to revert to 2 traffic lanes in this area then the yellow box will no longer be an issue.'

(Proposer: Cllr. T. Moloney 15/208)

The report of the Director of Services stated that Green Routes are considered to be essential and a very beneficial development for the City. They have helped greatly in the improvement of public transport journey times and passenger numbers. Council policy is to continue to expand and improve Green Routes throughout the city. The South West Strategic Travel Corridor study is in progress and Wilton Road is being examined as part of same. Recommended improvements in support of sustainable travel will be brought to Members in due course.

### 9.9.4 <u>REVIEW ROAD LANE LAYOUT ON SOUTH MAIN STREET R847 THROUGH</u> <u>WASHINGTON STREET JUNCTION TO SOUTH MAIN STREET ROAD R608</u>

An Chomhairle considered and approved the report of Director of Services dated 17th September 2015 on the following motion which was referred to the Committee by An Chomhairle.

'That Cork City Council would review the current road lane layout on South Main Street R847 through Washington street junction to South Main Street road R608.

There is 2 lanes coming up South Main Street R847, the left hand lane is for turning left & straight ahead, the right hand lane is for turning right only. There are major delays on the traffic going straight ahead due to the fact the cars turning left are often delayed by the fact that Washington Street traffic is busy & there is little of no space for the cars turning left to go, causing a back log down South Main Street as far as North Main Street. A possible solution for this would be if the right hand lane was changed for traffic to go straight & turn right as there is a much better flow of traffic turning right than there is turning left and make the left hand lane turning left only increasing the flow of traffic all round in my opinion.'

(Proposer: Cllr. T. Moloney 15/209).

The report of the Director of Services stated that the suggested changes and overall junction layout will be reviewed as part of an upcoming assessment in late October. If efficiencies or improved safety measures can be identified these will be implemented as soon as possible.

#### 9.9.5 SPEED RAMP IN BRIDE VALLEY VIEW

An Chomhairle considered and approved the report of Director of Services dated 17th September 2015 on the following motion which was referred to the Committee by An Chomhairle.

'Can Cork City Council install an extra speed ramp in Bride Valley view Fair Hill to reduce the speed of traffic.'

(Proposer: K. Collins 15/215)

The report of the Director of Services stated that Bride Valley View, Fairhill can be assessed to determine the extent of the problems that exist in order to identify any possible mitigation measures that could be provided there. However, there is no funding available for a traffic calming programme in 2015.

Any identified traffic calming solutions can be put forward for consideration in any future programme.

## 9.9.6 **PROGRESS REPORT ON TRAFFIC SURVEYS**

An Chomhairle considered and approved the report of Director of Services dated 17th September 2015 on the following motion which was referred to the Committee by An Chomhairle.

'That Cork City Council provide a progress report on traffic surveys conducted previously by the City Council on the use of heavy goods vehicles of roads through housing estates in the Fairhill/Farranree area including if consideration has been given to traffic-calming measures.'

(Proposer: Cllr. M. Nugent 15/216)

The report of the Director of Service stated that a number of surveys looking at the volumes and speeds of HGV's through the Fairhill/Parklands and Farranree area have now been undertaken. Any traffic calming measures need to take consideration of the current bus routes operating in the area. Considerable further work is required to identify the most suitable routes for vehicles and to assess signage requirements and possible traffic calming measures along the routes. Resources permitting we hope to undertake this work in 2016.

## 9.9.7 STREET AUDITS

An Chomhairle considered and approved the report of Director of Services dated 17th September 2015 on the following motion which was referred to the Committee by An Chomhairle.

'That Cork City Council would undertake regular "Street Audits" to identify what improvements are required in the public realm to make it safe, attractive and unified place.'

(Proposer: Cllr. J. Buttimer 15/221)

The report of the Director of Services stated that Road Safety Audits are commonly undertaken as part of the design & construction process for new projects. Condition surveys or user audits are less common and tend to be undertaken as part of broader studies. General street audits are desirable however there is currently no funding available to undertake this work. The matter will be revisited if funding becomes available

# 9.9.8 DOUBLE YELLOW LINES OPPOSITE 18 MOUNT PLEASANT AVENUE

An Chomhairle considered and approved the report of Director of Services dated 17th September 2015 on the following motion which was referred to the Committee by An Chomhairle.

'That double yellow lines be placed on the section of road directly opposite 18 Mount Pleasant Avenue, Friars Walk.'

(Proposer: T. O'Driscoll 15/227)

The report of the Director of Services stated that the section of road directly opposite 18 Mount Pleasant Avenue, Friars Walk can be assessed to determine the extent of the problems that exist in order to identify any possible mitigation measures that could be provided there.

Any identified measures can be put forward for consideration in any future programme.

#### 9.9.9 **RESIDENTS ONLY PARKING**

An Chomhairle considered and approved the report of Director of Services dated 17th September 2015 on the following motion which was referred to the Committee by An Chomhairle.

'That Cork City Council allocate "Residents Only" Parking on Audley Place down to the top of Patricks Hill on the side of the road with the houses only. There is adequate public parking on the other side of the road for public parking, and residents quite often have difficulty parking outside the front door of their houses as motorists not living locally are parking directly outside these houses and leaving their cars there for long periods of time seriously inconveniencing the residents of Audley Place.'

(Proposer: Cllr. J. Kavanagh 15/231)

The report of the Director of Services stated that on-street parking constitutes a significant public asset, which must be managed in a manner that balances the use of this limited resource between the needs of residents, businesses, shoppers, visitors, tourists and the disabled.

The Residents Parking Permit Scheme allows for a resident who is the owner of a vehicle and who lives in a pay parking zone to apply to Cork City Council for a permit, which allows their vehicle to be parked without limitation as to time in any parking bay on any of the streets within the zone to which the permit relates. It is not possible to allocate specific parking bays for the exclusive use of particular permit holders.

#### 9.9.10 <u>REPAINT THE DOUBLE YELLOW LINE AND ERECT BOLLARDS AT THE</u> <u>BOTTOM OF TOWER STREET</u>

An Chomhairle considered and approved the report of Director of Services dated 17th September 2015 on the following motion which was referred to the Committee by An Chomhairle.

'That to facilitate sight lines for vehicles turning right at the bottom of Tower Street, the double yellow lines are repainted, - and bollards erected, - to ensure unobstructed visibility at this busy junction, that no parking is enforced at this location and that a 'no left turn' sign is erected at the entrance to the new housing development on Evergreen St near Parkowen.'

(Proposer: Cllr. M Finn 15/233)

The report of the Director of Services stated that the junction of Tower Street and Barrack Street as well as the entrance to the new housing development on Evergreen Street, near Parkowen can be assessed to determine the extent of the problems that exist in order to identify any possible mitigation measures that could be provided there.

Any identified measures can be put forward for consideration in future works programme.

### 9.9.11 **REPAIR PUBLIC LIGHTING (POLE 3) ON CHURCH ROAD, BLACKROCK**

#### An Chomhairle agreed to refer this item back to Committee

'That Cork City Council reports on the status of public lighting (pole number 3) on Church Road, Blackrock and takes urgent action to repair or replace the light. In a response to a previous motion I proposed (14/425), a report from the Roads Directorate dated 31st December 2014 suggested this pole would be repaired early in the New Year, yet it is still not working.'

## 9.9.12 **REPAIR FOOTPATHS IN MCGRATH PARK, CHURCH ROAD, BLACKROCK**

'That Cork City Council take urgent action to repair and renew the footpath surfaces within McGrath Park, Church Road, Blackrock. The footpaths are in a dilapidated condition and urgently require attention.'

Cork City Council might match the amount donated by the public Euro for Euro to show its commitment to the housing adaptation problem.'
