# 4.2 **EVENTS CENTRE**

In response to the following question submitted by Comhairleoir M. Finn, a written reply was circulated as outlined below:-

Has there been any progress regarding the proposed Event Centre at the former Beamish & Crawford site and could the CE outline in the reply the nature and frequency of interactions with all involved parties?

# REPLY

As previously advised all parties have continued to work together to progress this project, with the appropriate legal structures having being put in place by Live Nation/BAM and there has been agreement in principle on all the substantive issues in the funding agreement. All parties will enter into the agreement as the detailed design is completed and further certainty is achieved on the cost risks involved. This will also inform the construction programme.

Live Nation / BAM are working to mobilise their design team so that it can be fully engaged once corporate approval is obtained by Live Nation in Ireland.

# 4.3 **PROPOSAL TO DEVELOP A GREENWAY ON ABANDONED RAIL LINE**

In response to the following question submitted by Comhairleoir S. O'Callaghan, a written reply was circulated as outlined below:-

To ask the Chief Executive for an update on the proposal to develop a greenway on the abandoned rail line from Cork to Waterfall Station, from Waterfall Station to Kinsale Junction, from Kinsale Junction to Farrangalway Station and from Farrangalway Station to Kinsale Town.

# REPLY

The City Council recently secured grant funding from the National Transport Authority, in the amount of  $\notin$ 80,000, to progress the preliminary design of the first project along the route referenced above i.e. The Viaduct to City Cycle Route Phase 1 (Viaduct to Kinsale Road). This project will enable the provision of new connections to adjoining areas along its extent and discussions are also underway with NTA regarding the continuation of this route to the City Centre via existing roads with connections to Tramore Valley Park. The remainder of the old rail network referred to above falls outside the administrative area of the City Council.

The Design Team procurement documents for the Viaduct to City Cycle Route Phase 1 will issue later this month. The preliminary design is scheduled to be completed by the end of Q2 2022 and the Part 8 Planning process is scheduled for Q3 2022 with detailed design, tender and construction to follow thereafter. It is expected that these facilities will be delivered under the current five year investment framework and Members will kept appraised of progress in the delivery of same.

#### 4.4 VACANT CITY COUNCIL HOUSING UNITS

In response to the following question submitted by Comhairleoir M. Nugent, a written reply was circulated as outlined below:-

Can the CE clarify the average turnaround for vacant City Council housing units? What is the target for this year in returning vacant housing units to housing allocations out of the total vacant housing stock.

#### REPLY

The turnaround time is currently 64 weeks. This includes the time taken to interview and process allocations to tenancy in addition to the period required to undertake necessary maintenance works in order to bring a property back to habitable standards.

The annual target number is normally in the region of 250. However, there will not have been that level of vacants arising over 2021 and in our submission to the Department we had only indicated approximately 160 vacants available for return. As of the end of August, the City Council had 217 properties requiring repairs; we expect most of these to have been returned to stock by the end of the year.

#### 4.5 **BIODIVERSITY MEASURES**

In response to the following question submitted by Comhairleoir D. Boyle, a written reply was circulated as outlined below:-

To ask the Chief Executive to highlight any additional biodiversity measures taken by the Council in the year to date, as in the amount of public parks rewilded, the type and quantity of pollinator friendly plants planted, any reduction in the cutting of grass verges or the use of chemical based weed killer?

# REPLY

Additional biodiversity measures taken during 2021 include the following:

- Creation of wildflower meadows in parks, amenity walks, roadside verges, and open space areas.
- Planting of native Irish tree species
- Planting of pollinator friendly herbaceous perennials
- Over 70% of seasonal floral planting is now pollinator friendly.
- Installation of bug hotels.

Approximately 25% reduction in the use of chemical herbicides in amenity areas during 2021.

Trials on the use and effectiveness of organic herbicides, mechanical weed control and mulching were carried out during 2021. The findings of these trials will feed into a review of herbicide use later this autumn with a view to reducing chemical herbicide use in amenity areas by 90% in 2022.

As agreed at the Roads & Transportation SPC, a draft revised parking permit policy will be submitted to the committee at their next meeting. The revised parking permit policy will include proposals made by Members at the last SPC. If agreed, or agreed with amendments, the revised parking permit will be submitted to Council for consideration.

The request to extend the operational hours is currently being considered and a report in relation to the possible implementation of this request, the potential for displacement, the limitations for enforcement etc. will be prepared and presented to the Local Area Committee.

#### 4.8 **POLICY OPTIONS – LED LIGHTING**

In response to the following question submitted by Comhairleoir O. Moran, a written reply was circulated as outlined below:-

To ask the Chief Executive what policy options are available to the city with regards to the choice of public LED lighting, especially with regards to the strength, colour and angle of lighting, the preferences of communities, and effects on wildlife in the city.

#### REPLY

The information requested is contained in Cork City Council's Exterior Lighting Design Requirements, Guidance & Specification Manual for Lighting Equipment Supply, Installation & Maintenance and can be found on Cork City Council's website under the public lighting section at the following link:

The query responses are extracted from the document as follows:

Lighting levels are designed in line with public lighting standard BS EN 13201 and Transport Infrastructure Ireland (TII) standards DN-LHT-03038 (Design of Road Lighting for the National Road Network)

The colour temperature policy is found in section 8.4.3 of the document "Exterior Lighting Design Requirements, Guidance & Specification Manual for Lighting Equipment Supply, Installation & Maintenance (Rev 10)". Cork City Council have implemented a policy of 3000K (Warm White) colour temperature light fittings. Existing lantern installations may vary.

The Dimming profiles available for use for scheme design can be found in section 8.4.4 and 8.4.5 of the document "Exterior Lighting Design Requirements, Guidance & Specification Manual for Lighting Equipment Supply, Installation & Maintenance"

The desired upward Light Output Ratio of new luminaires installation is 0%. Cork City Council promotes the Campaign for Dark Skies and the Reduction of Obtrusive Light in our Exterior Lighting Design Requirements, Guidance & Specification document to ensure the effects of lighting on citizen and wildlife within the city is minimised. Cork City Council follows best practices in minimising light pollution and light spill.

Lighting is designed and specified according to environmental zones as follows:

Zone E0	<ul> <li>Astronomical Observable dark skies, UNESCO starlight reserves, IDA dark sky places</li> </ul>
Zone E1	<ul> <li>Areas of Outstanding Natural Beauty, Conservation Areas, Sites of special Scientific Interest, Environmentally Sensitive Areas, Special Areas of Conservation and Urban Conservation Areas.</li> </ul>
Zone E2	<ul> <li>Areas of low district brightness (rural locations outside Zone E1) corresponding to high sensitivity on map.</li> </ul>
Zone E3	<ul> <li>Areas of medium brightness (urban locations) corresponding to medium sensitivity on map.</li> </ul>
Zone E4	<ul> <li>Areas of high district brightness (urban centres with high night –time usage) corresponding to low sensitivity on map.</li> </ul>

In accordance with the above environmental zones, new schemes are reviewed and consider wild life on a case by case basis to ensure the best design possible in accordance with best practice guidance from the Institution of Lighting Professionals.

The report stated the importance of involving the voices of children and youth in public affairs and in decision-making is well appreciated and encouraged by the City Council and the Council supports a number of initiatives to engage and involve young people in decision making, the following of which are examples:

# **<u>Climate Change Adaptation Strategy</u>**

On the request of the Lord Mayor, Cork City Council, through the ETB, engaged directly with a number of schools to prepare the Climate Change Adaptation Strategy. Schools attended workshops and their deliberations were written up and recommendations were integrated into the Strategy.

# Freedom of the City Children's Art Programme

As part of preparation of the City Development Plan, Cork City Council worked with the Planning Department of UCC and the Glucksman to develop a school's programme where children were asked to imagine if they had 'freedom of the city' to plan the city. This was a successful programme, stimulated thought by children and conversation on the future of Cork City in the homes.

# Comhairle na nÓg

For many years the City Council has supported and facilitated Comhairle na nÓg and particularly in the past number of years, has engaged with this group to involve them in the formulation of the LECP, ias well as inviting them to present to the LCDC on a number of occasions and to Cork City Council meetings. Cork City Comhairle na nÓg is also regularly invited and consulted by the HSE and by the Arts Office on the promotion and dissemination of information to younger cohorts. The City Comhairle na nÓg is managed through a Service Level Agreement ty Youth Work Ireland which also includes them on national consultative projects

#### **Young Social Innovators**

YSI is jointly supported by Strategic and Economic Development, Corporate Affairs and International Relations and Community, Culture & Placemaking to encourage engagement with Local Government and more recently the Draft City Development Plan.

#### Women's Caucus

The Women's' Caucus was established by Cork City Council in 2020 and as part of that initiative a schools engagement project is proposed to encourage female involvement in public affairs and politics.

Through the long-established tradition of the Lord Mayor's School Visits, the younger citizens of Cork City have always enjoyed a positive relationship with the civic authority. The Council is committed to ensure that this relationship continues to be strengthened by engaging with young voices in decision-making in a broad range of important policy areas and functions.

'That Cork City Council will develop a climate action portal on its website, showing the actions it is taking across all areas of the organisations for the city to be a leader on climate action, and with practical supports for residents, neighbourhoods and businesses in the just transition to a zero-carbon city.'

(Proposers: Cllr. O. Moran, Cllr. D. Boyle 21/267)

The report stated that in reviewing this motion, it was thought important to identify existing resources and initiatives that are in place and so consulted with the Department of Environment, Climate and Communications, CARO Regional Offices in Cork, Dublin Metropolitan, Eastern & Midlands, and Atlantic Seaboard North and Cork City Council's Climate Action Team.

The Department of the Environment, Climate and Communications have responded as follows with respect to enquiries regarding a 'sectoral portal':

A national version might be considered to be the Climate Action Plan 2019 (CAP2019) – targeting the actions to be taken by Departments and organisations rather than individuals/residents. The reporting on the CAP2019 can be found at:

gov.ie - Climate Action: Important Publications (<u>www.gov.ie</u>)

The CAP2021 will obviously have a greater level of ambition for the Departments and Agencies and progress will be reported in a similar manner.

While there are no Department of the Environment, Climate and Communications proposals for a national web portal that would focus on the needs of residents, business and neighbourhoods, in terms of practical supports, the Climate Ireland website, the EPA website, and particularly the SEAI, provide a level of information and/or support to residents, neighbourhoods and businesses.

The SEAI has a YouTube channel with a lot of practical information in video format along with the various information leaflets available on its website. Climate Ireland also has a wealth of information that can be accessed.

In terms of initiative by individual Local Authorities, the CAROs have responded as follows:

Dublin Metropolitan CARO state that South Dublin Council are currently developing a climate change section on their website.

Eastern & Midland CARO report the some Local Authorities in their Region are putting climate action "sections" onto their websites with a view to signposting their work in the climate area – adoption of strategies, electrification of fleet, flood schemes, etc.

Atlantic Seaboard North CARO have replied that Galway city Council are looking to develop a climate action section within their website. The intention is to provide links to agencies/departments involved in climate action and provide information and updates relevant at a local level, such as community funding, updates on DZs, Galway City Projects, etc.

For Atlantic Seaboard South, no Local Authorities have, to their knowledge, advanced a proposal for a climate action 'portal' as envisaged by Cork City Council.

As has been pointed out in the Department of Environment, Climate and Communications response, there is a lot of information already available (e.g., SEAI) and as this information is subject to change, continuous review and updating would be required should it be available on a Local Authority website.
